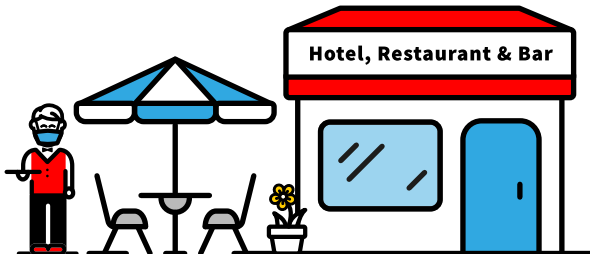


# COVID-19 MEASURES IN PLACE AS OF 24.06.2020

## SPECIFIC MEASURES



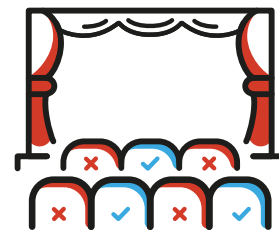
### Horeca sector:

- Only seating is permitted.
- Max. 10 people per table or several people from the same household.
- The tables must be separated by a distance of at least 1.5 metres or by a barrier or physical separation.
- Closing at midnight at the latest.
- Wearing the mask is compulsory for clients when not sitting at the table.
- Wearing the mask is compulsory for personnel in direct contact with the customer.

- Physical contact during **sports activities** is prohibited.
- Exceptions for elite athletes, defined in application of article 13 of the amended law of 3 August 2005, and for sports programmes organised by the Sportlycée, with the exception of competitions.



- **Heat bath facilities** (sauna, hammam etc.) may only be occupied by one person or by several members of the same household.



- Physical contact during **cultural activities** is prohibited.
- Exception for professional theatre and film actors as well as professional dancers.

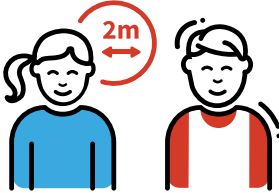

### OBLIGATION TO DISTANCE OR WEAR A MASK



#### Gatherings of more than 20 people in public or in places open to the public:

- Provision of **assigned seating** for those attending the event.
- Respect the **distance of two meters** between people or wear a mask.

At **fairs, exhibitions and markets**, the wearing of a mask is compulsory, when an interpersonal distance of two metres cannot be maintained.



The obligation to assign seats does not apply to the exercise of the **freedom of demonstration** or to **funerals held outdoors**.

During gatherings in **private places**, distancing measures and the wearing of masks are recommended.

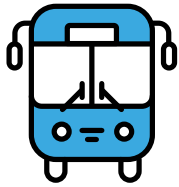
**However, it is recommended to apply the distance measures, respectively to wear a mask or an equivalent device when the distance of two meters cannot be respected.**

## WEARING A MASK IS MANDATORY



For **public transport** users  
(bus, train, tram).



For **activities that are open to the public**  
(shops, ticket offices, cultural activities,  
leisure activities, etc.).

## EXEMPTED FROM THE MANDATORY WEARING OF MASKS:



Children **under the age of 6** and  
minors **under the age of 13** for  
**outdoor activities**.



**Cultural and sports actors**  
**during the exercise of their**  
**activities.**



Disabled persons who are in  
possession of a **medical certificate**  
justifying this derogation and who  
implement health measures to  
prevent the spread of the virus .

## PROHIBITED ACTIVITIES



**Fairs and exhibitions** are prohibited  
(except in the open air).



**Nightclubs** must remain closed.
